Subject: Request to Pass the Improving Seniors' Timely Access to Care Act (H.R. 8702/S. 4532)

Speaker Johnson, Leaders Schumer, Jeffries, and McConnell:

On behalf of the Regulatory Relief Coalition (<u>RRC</u>), a coalition of national physician organizations and our allies seeking to reduce regulatory burdens that interfere with patient care, we urge you to prioritize passage this session of the bipartisan, bicameral *Improving Seniors' Timely Access to Care Act* (<u>H.R.</u> <u>8702/S. 4532</u>) which has overwhelming stakeholder support and is urgently needed to reduce delays in health care for our nation's seniors.

The *Improving Seniors' Timely Access to Care Act* is bipartisan legislation that will tackle the overuse and abuse of prior authorization (PA) by Medicare Advantage (MA) plans, which threatens access to medically-necessary care and increases provider administrative burden. The bill would codify and enhance elements of the Advancing Interoperability and Improving Prior Authorization Processes (e-PA) rule that was finalized by the Centers for Medicare & Medicaid Services (CMS) on January 17, 2024.¹

In an effort to help ensure swift passage in Congress, the bill sponsors made modest, mindful adjustments to the legislation to align with CMS' final e-PA rule and to reduce the Congressional Budget Office (CBO) score. Changes include a requirement for CMS to issue a report on implementing real-time decisions, an analysis on enrollee impact, and clarifying CMS's authority to modify the timeframes for making PA determinations.² To facilitate passage, we ask that you work with the leaders of the relevant committees of jurisdiction to expedite Congressional Budget Office (CBO) scoring of the new bill.

The RRC has been advocating for the *Improving Seniors' Timely Access to Care Act* since it was first introduced in 2019. In the 117th Congress, the bill passed the House with 380 combined cosponsors — 53 senators and 327 representatives.³ In June 2023, 233 Representatives and 61 Senators showed their bipartisan support of PA reform in MA by urging the Department of Health and Human Services and CMS to finalize pending rules to reign in the overreaches of MA plans that delay and deny care through utilization management tools like PA.⁴ In July 2023, the Ways and Means Committee passed legislation out of committee that included the *Improving Seniors' Timely Access to Care Act* provisions.⁵

Senators Roger Marshall, MD (R-KS), Kyrsten Sinema (I-AZ), John Thune (R-SD) and Sherrod Brown (D-OH), and Representatives Mike Kelly (R-PA), Suzan DelBene (D-WA), Ami Bera, MD (D-CA), and Larry Bucshon, MD (R-IN) introduced the bill on June 12, 2024, with 42 Senators and 130 Representatives as original cosponsors. The bill now has 55 Senators and 220 House cosponsors – including 15 Senate Finance Committee members, 36 Ways & Means Committee members, and 33 Energy & Commerce Committee members.

It is rare for legislation to enjoy such overwhelming approval from members of Congress and nearly 500 hundred stakeholder organizations representing patients, providers, the medical technology and biopharmaceutical industry, and some insurance companies—compelling evidence of the bill's consensus-driven, bipartisan, reasonable approach to improving access to health care for our seniors.⁶

This legislation is at a critical junction. Our coalition firmly believes this opportunity to pass strong, bipartisan policy is one that must be seized by our nation's leaders to ensure that patients do not face unnecessary delays and denials of medically necessary care due to MA plans' prior authorization requirements. We urge you to include this legislation in any must-pass legislation this year.

Thank you for your leadership to on this important issue, and the RRC and its members stand ready to work with you to secure passage of the *Improving Seniors' Timely Access to Care Act* this year.
